Personal identification information

Use of information

- To protect our Products and Services. We may process Members information as part of our efforts to keep our Products and Services safe and secure, including fraud monitoring and prevention.
- To identify usage trends. We may process information about how Members use our Products and Services to better understand how they are being used so we can improve them.
- To determine the effectiveness of our marketing and promotional campaigns. We may process Members information to better understand how to provide marketing and promotional campaigns that are most relevant to them.

- To save or protect an individual's vital interest. We may process Members information when necessary to save or protect an individual's vital interest, such as to prevent harm. Besides, we do not sell, trade, or rent Members' personal identification information to others.
